 - *Good stuff*: Audience shares what they like about the project/work so far.
 - Wondering stuff: Audience shares their questions and wonderings for consideration.
 - Next stuff: Audience shares suggestions for sustainability/scale, ideas for resources, and possible ways to enhance the project/work
- **Group Reflection (3-5 min):** Whole group reflects on feedback from critical friends and presenter identifies next steps
